

IT Tip Sheet

United Educators' (UE's) learning programs play an important role in ensuring the safety of students, staff, and faculty while allowing your institution to focus on delivering on your academic mission.

To ensure learners are set up for successful training, please share the following information with your IT team.

Hosting Information

The UE Learning Portal is hosted on the Docebo Learning Management System (LMS), a cloud-based platform used to deliver and manage online training and education content.

Automated Emails

The Learning Portal distributes automated emails to learners when:

- Learners use the “Forgot password?” feature.
- Learners complete a course and are emailed the completion certificate.

Whitelisting

To ensure learners receive emails from the learning portal, please send the whitelisting information below to your IT team. This helps prevent learning portal emails from being blocked or sent to spam folders.

- **We recommend setting these conditions on sendgrid emails coming from @learn.ue.org: (Envelope Sender Email Address contains “em3505.ue.org” OR Envelope Sender Email Address contains “em5420.ue.org”) AND Sender Hostname contains “sendgrid.net.”**
