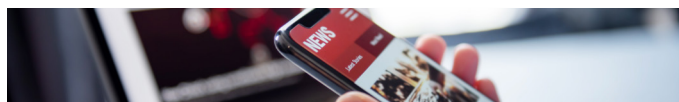

FERPA: Protecting Student Privacy

Learn when and when not to release student records to avoid violations of the Family Educational Rights and Privacy Act (FERPA), a federal law that protects the privacy of student educational records.

The Health Insurance Portability and Accountability Act, or HIPAA, is a 1996 federal law that regulates the privacy and security of medical information. HIPAA gives patients a number of rights regarding how that information can be disclosed, shared, or transmitted.

Protecting Payment Card Information

Employees learn common risks associated with handling payment card information and how to avoid unauthorized disclosures. It is an element of required annual compliance training as called for by the payment card industry data security standard (PCI DSS).

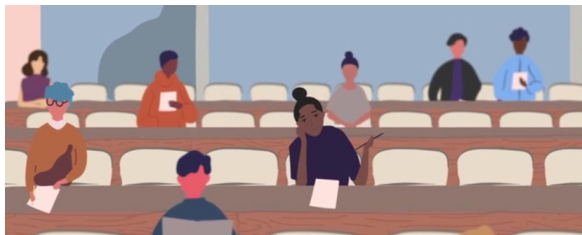

Misuse of alcohol and drugs can have a wide range of serious consequences, including academic failure, injury, and death. The Centers for Disease Control and Prevention recently stated that almost 70% of drug overdose deaths involved opioids. This course collection emphasizes a harm-reduction approach that teaches students ways to use alcohol responsibly and informs them of the misconceptions and dangers associated with the illicit use of opioids.

Sexual Assault and Misconduct

Title IX Collection

This course collection was developed to help institutions meet training obligations under Title IX and the Violence Against Women Act (VAWA) and is meant to complement other prevention efforts at your institution.

In June 2022, the U.S. Department of Education (ED) released proposed regulations related to Title IX that will govern how educational institutions conduct inquiries into allegations of sex discrimination, including student sexual misconduct. Once they are final, our courses will be updated to reflect the new regulations.

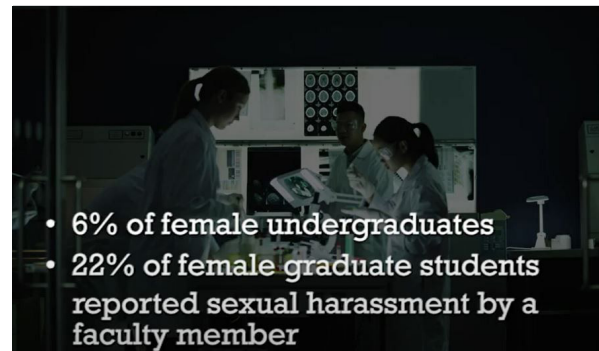

The Federal Trade Commission's (FTC's) Red Flags Rule requires all institutions to implement an identity theft prevention program to detect the "red flags" of identity theft, take steps to prevent the crime, and mitigate damage. This course will help employees comply with and understand the rule.
