Education-Specific Scenarios

Education-specific, real-life scenarios are the basis for EduRisk learning programs. When individuals understand the risks posed by certain situations, they are more likely to avoid them or respond in a manner that prevents an incident. EduRisk scenarios are based on analysis of situations that have been reported to UE over more than 30 years of managing education claims.

As federal and state laws focus on training to address important issues in education such as Title IX and VAWA compliance, EduRisk learning programs can help. Online courses such as *Mosaic: Prevent Sexual Violence Together* and *Impressions* educate students, faculty, and staff to prevent and report sexual assault.
